## Upute autorima

Za Znanstveni skup „Physiotherapia Croatica“ moguće je prijaviti izvorni znanstveni rad, sustavni pregled literature (engl. *systematic reviews*) i meta analizu (engl. *meta-analyses*). Sažetak rada treba biti napisan u fontu „Times New Roman“ (TNR), veličine slova 12 pts te zajedno s naslovom i ključnim riječima (minimum 3, maksimum 5 riječi) ne bi trebao iznositi više od 250 riječi. U sažetku rada treba istaknuti slijedeće podnaslove: UVOD, MATERIJALI I METODE, REZULTATI, ZAKLJUČAK, (TNR, 12 pts, bold, poravnato lijevo). Cjeloviti rad uz navedene dijelove bi trebao sadržavati i RASPRAVU. Cjeloviti rad treba biti veličine do 12 stranica (uključujući slike, tablice, grafikone), dvostrukog proreda, sa marginama 2,5cm. Naslov, sažetak rada, titule autora i naziv ustanove trebaju biti na hrvatskom i engleskom jeziku, dok cjeloviti rad može biti na hrvatskom ili engleskom jeziku. Reference je potrebno navesti prema JAMA stilu (<http://guides.med.ucf.edu/jama>).

Molimo podcrtati ime autora koji će prezentirati rad. Cjeloviti radovi biti će objavljeni u suplementu časopisa Physiotherapia Croatica. Na kraju rada potrebno je navesti e-mail autora za korespondenciju. Cjeloviti rad treba biti dostavljen do zadnjeg dana roka za slanje radova (15. ožujak 2023. godine). Svi radovi prolaze postupak recenzije. Ukoliko recenzenti utvrde da su potrebne bilo kakve dorade i dodatna objašnjenja vezana uz rad, biti će poslano isključivo autoru za korespondenciju. Kada je rad prihvaćen od strane recenzenata biti će poslana potvrda o primitku rada autoru za korespondenciju. Autori su u cijelosti odgovorni za sadržaj objavljen u radu i trebaju predati tekst koji do sada nije prezentiran na stručno-znanstvenom skupu i/ili objavljen u časopisu.

#### ARTICLES IN JOURNALS

**Please note:** AMA style requires the use of standard abbreviations for all references, when applicable. Abbreviations for many common medical journals can be found in the [AMA Manual of Style](#). Additional abbreviations can be searched in the [PubMed Journal Database](https://www.ncbi.nlm.nih.gov/nlmcatalog/journals) (<https://www.ncbi.nlm.nih.gov/nlmcatalog/journals>).

**Example:** New England Journal of Medicine ----> *N Engl J Med*

**Article titles** should be in sentence case, meaning only capitalize the first word, proper pronouns, acronyms and the first word after a colon.

## CITING SOURCES WITHIN TEXT

### GUIDELINES FOR CITING REFERENCES WITHIN TEXT

- Cite references that are retrievable in text, tables, and figures in consecutive order using superscript Arabic numbers.
- Use commas to separate multiple citation numbers in text.
- Corresponding references should be listed in numeric order at the end of the document.
- Unpublished works and personal communications should be cited parenthetically (and not on the reference list).
- Superscript numbers are placed outside periods and commas, and inside colons and semicolons.

#### Examples:

The report<sup>1</sup> found that...

As has been noted previously,<sup>2</sup>

This argument was refuted in another study.<sup>3</sup>

Other reports<sup>4,5</sup> confirm these findings. **(Note: Two sources are cited.)**

"...as has been the conclusion of this author."<sup>6</sup> **(Note: Use after direct quotation.)**

In recent reports<sup>1,3-5,9</sup> surgical outcomes have been... **(Note: Multiple sources cited; not all are consecutive.)**
